Shanthi Nilayam is a social organisation working for education and rehabilitation of Intellectual disable children since 1993 at Paruthivilai, Kanyakumari District, Tamilnadu, started by the Sisters of Adoration of the Blessed Sacrament under the guidance of Kanyakumari Social service society of Diocese of Thuckalay, following the vision of our heavenly Patron Mar Thomas



Kurialacherry, who had very high ideals about the education of women and children, the poor and the less fortunate people in society. Shanthi Nilayam was legally registered on 20th July 1998 under the Tamilnadu Societies Registration Act (1975). 300 intellectual disabled children and their families from rural and semi-urban areas of Kanyakumari district in Tamilnadu are benefitting from this organisation.

KEY OUTCOMES & IMPACT OF THE YEAR

- 10 Vocational trained students are being placed in different agencies such as mechanical shops, helpers in hospitals, office assistants, helpers in medical stores, vehicle cleaning etc.
- 15 students were admitted to Regular schools in 2020-2021 through Mainstream Education Programme.
- 6 students have got passed in 10th Exam. They have applied for higher studies in technical Institutions.
- Through Physiotherapy, children are able to stretch their limbs and remain fit. It has improved the mobility of children in running and walking. General health of the children is improved and physical fitness is increased.
- Speech therapy has developed confidence in students to speak or at least to utter words. Students have developed their skills in verbal and nonverbal communication.
- The children have been infused with self-confidence and a sense of satisfaction of being useful in one way or the others.
- Through the Organization development programme staff have developed their management and teaching skills through the online training programme.

NEW INITIATIVES DEVELOPED

Play Therapy Unit

Play therapy unit was newly constructed in Santhi Nilayam school with the support of Er.S. Cyril (Ideal Constructions) the President, Rotary club of Sub Urban, Nagercoil.



The inauguration ceremony of the play therapy unit was held on 8/11/2020by the District Governor of Rotary Club, Rtn. Murugadoss, in the presence of major donor Gr. V. Shunmugam, Sugadev, and other Rotarians. This unit functions to assess and develop the sensory, functional and motor activities of development delayed children.

Website & Youtube

Shanthi Nilayam launched its website & youtube channel. The website is well updated for providing current information to the beneficiaries and stakeholders. Youtube channel is maintained by our staff and videos of various activities and programmes are uploaded on a monthly basis.

FM Radio Programme

One of our school teachers Mrs Jesy shared her experience on FM Radio during the "Sathanaiyalar Neram" Programme. she also created awareness on Early identification of Intellectual Disability.

Online Training Programme

Special Educators from both schools participated in RCI approved online CRE programme. We also organized various training programmes for our staff to develop their skills in special education and management. Teachers conducted online training classes for our students and parents.



Covid-19 Relief Work

Both schools distributed Food materials to Disabled children's families during the covid-19 lockdown period. Nearly 50 poor and most vulnerable families were identified and supported through food package (10 kg Rice, Groceries, eggs and fruits,). Our staff made Mask at home and distributed them to disabled children families. We provided Counselling service during Covid -19 lockdown period to Parents who had depression



problems and were hard in handling Intellectual disable children at home received counselling over the phone. Since the hyperactive children were uncontrollable at home. It was a great challenge for the parents in handling these children at home. Our staff visited the houses of needed children's families and provided psychosocial counselling to the parents

Organizational development Programme

Niranthara is an Organizational development Training programme of the Dhwani Foundation. This programme aims to improve the efficiency, productivity and sustainability of NGOs through specially designed workshops modules followed by field support, assessment and governance engagement. Specific training is provided to



Ngo leaders, CFM (Compliance and Finance Manager), Fundraising manager and Programme manager. Workshops were conducted for board members to strengthen governance.

DETAILS OF PROGRAMS IN 2020-21 Early Intervention Centre

The children with delayed milestones are identified at the earliest and necessary intervention techniques are used to enable them to achieve a normal life. It consists of children from 0-6 age. The aim of this programme is to improve the mental and physical capacity of each one, by giving therapy and training.



This makes the body active by stimulating the 5 senses. Many of these children are unable to speak, walk &see. Different therapies like speech and audiovisual are very essential to make these children better. 54 children are benefited from the early intervention programme. Children are divided and cared by special educators based on 1:8 ratio of the children. Tamilnadu Government's providing financial assistance through the of Commissionerate Welfare the Differently Abled, Chennai. Our District



Differently Abled Welfare officer provide timely assistance and guidance for the implementation of the programme. Since covid-19 threatened children not to come Centre these children were supported by our staff through house visits and guided through WhatsApp and telephonic conversation.

Special School Programme

Children above 6 to 18 years, who could not cope with the regular school curriculum, join in the special school programme, where they learn, functional skills, basic academic skills, Personal & Social skills. Children are categorised according to their IQ level and grouped as Caregroup, Pre-Primary, Primary, Secondary, Pre-Vocational categories. These children get



physiotherapy, speech therapy and occupational therapy along with the training to develop Co-curricular activities like sports, Dance, Music, Painting & Colouring, Swimming, etc. Due to the pandemic situation, during this academic year children were guided online.

Vocational Training

Above 18 Years of children are given Pre-Vocational Training and then they are trained in vocational trades like Photo frame making, Phenol making, Paper cover making star-making, tailoring, handkerchief making,

art and craftwork to become an independent and self-reliant individual to lead a life with dignity. We thankfully appreciate their co-operation and support.

Autism Training Unit

Children who are found with autism features are grouped separately and special trainings is planned to provide continuous training like Special education, sensory integration, speech and language therapy, occupational Therapy, Physiotherapy, Music therapy, play therapy, Hydro therapy, sand therapy and Behaviour Modification therapy. Tamilnadu Government is supporting for autism children through Chief Ministers



Comprehensive Health Insurance Scheme. We have nearly 40 autistic students. Currently, 21 students, age 4 to 15 years, are getting benefited through this scheme

CBR (Community Based Rehabilitation Centre)

Shanthi Nilayam developed 10 sub-centres in Kanyakumari district with the support of TDH Netherland As the project got over in 2013 we handed over the sub-centres to the CBOs to run the centres. Local benefactors provide the necessary care and facilities to run the CBR centre successfully.



MEDICAL INTERVENTIONS

Speech Therapy

Speech Therapy is the most important part of intervention services for children with developmental disabilities for their cognitive and social development. Apart from having intellectual challenges, they also have associated speech problems in the articulation of speech, social communication and social interaction. Speech therapy is given by the trained speech therapist and children are getting improvement.



Physiotherapy

Physiotherapy is conducted regularly for our children. The main aim of this therapy is to reduce their physical deformities and increase their mobility. Children who were unable to walk in the beginning stage are able to walk after coming to our institution. Children show interest to get physiotherapy. Parents also are happy to send their children to school.



Occupational Therapy

Occupational therapy is given to help the students to increase their functional daily life. independence in Periodical assessment is conducted by Occupational therapist. Through this therapy, students have benefited in general activities of daily living, sensory processing issues. Children with spectrum autism disorder have improvement in their eye-hand coordination and Visual perception activities.



Medical Check Up

Medical check-up is conducted for the children and medicines are provided for the diagnosed children. Parents are advised to give medicine regularly at home. Our medical team takes care of the children when they are having any health problems.



Guardianship

Guardianship is one of the schemes of the National Trust, Ministry of Social Justice and Empowerment Government of India, which provides a legal power to guardian to take all legal decisions on behalf of the person and the property of the Intellectually disabled children. 36 students above 18 years old got Guardianship certificates last year, through District local level committee



NIRAMAYA Health Insurance Scheme

Niramaya is a Health Insurance scheme of the National Trust, Ministry of Social Justice and Empowerment Government of India. 30 Intellectual Disabled students are enrolled under this Niramaya scheme.

HOME BASED INTERVENTION PROGRAMME

The children who are unable to attend school due to severe retardation are given special attention and care, by the teachers. They go to each one's house and teach the parents how to take care of their child. The teachers also give awareness to their siblings. Through this, the mentality of the family members is changed and they start loving and accepting them as their own. The depressed parents find a ray of hope through this counselling.



AWARENESS PROGRAMME

Awareness Programmes are conducted for the Nursing College Students, B.Ed College Students and art & science college students as a Social responsibility to reduce the birth of children born with Mental Retardation, especially to avoid marriages within their close relatives



and to take necessary precautions and regular check-ups to the pregnant mothers. The normal school students are also encouraged to come and spend a day with our Special Children to create an inclusive set-up in which they learn to treat our differently-abled children with due courtesy and respect and not to leave them if they find anything abnormal, but to accept them and support them to lead a near to normal life.

CULTURAL CELEBRATION

All important festivals like Pongal, Onam. Christmas. Diwali are celebrated with its due importance to impart their cultural values. Children's day, Teachers day, School Sports day and Annual day are also celebrated and the values of these celebrations are also made known to them. Apart from these celebrations the children are encouraged to take part in various competitions like



sports, quiz programmes, painting & drawing, dance, etc. And they also win prizes. These activities enable them to take part and enjoy these occasions and also helps them to develop self-esteem and confidence. Due to the pandemic, all the activities were conducted online and the prizes were distributed offline.

BTK FEST

We organised a district Special School talent competition on 12th January in remembrance of our Founder Mar Thomas Kurialacherry's Birthday. This year we conducted fancy dress competition for children and story writing for teachers through virtual mode. We distributed prizes for the winners.



TRAINING AND SPECIAL ORIENTATION PROGRAMME FOR TEACHERS

Training programmes help the teachers to develop new strategies using the new trends and techniques. This programme creates a platform for the teachers to express their difficulties in teaching and to get suggestions and improvements. Once a month Teacher's meetings and orientation programmes are being conducted to assess the growth of students.

Teachers get guidance to create an action plan for every month. Teachers participate in CRE-Training Programme (Continued Rehabilitation Educational Programme) conducted in our district and other districts by NIEPMD (National Institute of Empowerment of the person with multiple Disabilities).
